

Flex Your Money Muscles Challenge Giveaway Official Rules

- Eligibility:** The sweepstakes is open to current members of Jovia Financial Federal Credit Union ("Jovia"); who are 18 years of age or older, residents of the United States of America at date of entry and open a new membership or qualifying product/service from May 30, 2025 through July 19, 2025. Employees, officers, directors of Jovia; and employees of any provider of the promotional consideration or advertising or promotional agency involved in the sweepstakes are not eligible to participate. All applicable federal, state, and local laws and regulations apply. **No purchase necessary to win.** Void where prohibited or restricted by law.

Winners will be notified within 4 days of random drawing via email and/or phone provided on member's account. Potential winners must choose and accept prize within seven (7) days of being notified. If a potential winner fails to timely respond or is disqualified for any reason, Jovia may, in its sole discretion, award the applicable prize to an alternate winner selected at random. Winners may be required to sign and return an Affidavit of Eligibility, Release of Liability, and an Advertising Consent Form within seven (7) days of notification.
